2:35 PM Duane Mitchell called the meeting to order.

Reviewed Agenda: The agenda was approved. Kari Johnson made a motion to approve the agenda and Melissa Boyer 2nd the motion.

Minutes: The April 19, 2021 minutes were approved. Shane Gorder made a motion to approve April minutes, Kari Johnson 2nd the motion.

Health Department Administration Report: Brittney Reported
General Health Department Updates –

- RCHD has shifted from mass COVID-19 Vaccine Clinics to Walk-In Clinics every Tuesday from 12:30 – 3:00pm. The one-dose (Janssen) Johnson and Johnson vaccine is offered the 1st and 3rd Tuesday and the two-dose Moderna vaccine is offered the 2nd and 4th Tuesday.
- Outreach to businesses – Immunization staff have been reaching out to the larger businesses in Richland County to let them know about our Tuesday walk-in

clinics and inquire if they would be interested in RCHD going on site to vaccinate interested employees.

- Last week, the Pfizer vaccine was approved for use in individuals 12 and up. Because of the population of our area and the minimum dose shipment of 1170, and current storage requirements, RCHD will continue to only offer the Moderna and Janssen vaccines at this time.
- Tomorrow and Wednesday of this week (May 18 & 19th), Pharm 406 Clinic, a mobile vaccine clinic, will be at Reynolds, offering both the Moderna vaccine to those 18 and older and the Pfizer vaccine to those 12 and older.

Performance Management –

Last month Brittney mentioned that the Department turned in Section I of our Public Health Accreditation Board (PHAB) Report, which was also sent out to members with the meeting reminder. The Department turned in Section II of the report on May 6 and it has been approved with comments and suggestions to consider as we prepare for reaccreditation in 2023.

Program Report: Jessica Gilbert reported on Volunteers in Action MT. She informed the Board about the name change because the community wanted a volunteer program that is more inclusive of all ages rather than a program that is only for those 55 + and to align with Communities in Action. She gave data on how volunteers help the community. With 308 volunteers the total hours served was 26,467.38 and these volunteers saved communities in northeast Montana region over \$719,912.73. The program continues to work with area groups to bring new services to the area or enhance existing services. Since the pandemic started over a year ago the volunteers have stepped up to ensure essential services continued. The volunteers delivered meals and groceries, contact traced and daily check-in calls for COVID activities, helped with drive through flu clinics, helped with vision and hearing screens in Richland County schools, and community recovery through vaccination clinics. The program has a website to connect volunteers and organizations.

Health Officer Report: Jacquelyn Free reminded everyone that it is tick and poison ivy season.

We have been monitoring up to 12 contacts since the last meeting. (This means doing daily phone calls or texting to check for symptoms and follow up on testing needs). Richland County had 1 hospitalized person since last meeting. The automated texting system "SARA Alert" for doing symptom checks by testing is working well.

5/17/2021 CURRENTLY RCHD: 3 active cases and 7 close contacts,

Exposures from travel to funeral or others traveling in; or they were ill 1-3 months ago and did not test until they now need a medical procedure; or they have no idea how they got it and most persons only name members of household as being exposed if they are ill. (attended a gun show, went to billings for appointments & shopping, travel to Hawaii, or within MT and ND)

COVID-19 case numbers on the state map are behind as RCHD works to enter the data into the state system for it to show up on the count. RCHD is working hard at catching up in this reporting data area. Fluctuations noticed statewide on the map due to counties getting data entered - not new cases.

Public Health Emergency Preparedness:

We are working on our COVID AAR (after action report) to identify improvements and strengths in the process of both disease case investigation and response with vaccination efforts.

NEW 4th Qtr Requirements: End of year report on preparedness efforts, Review and update the pandemic flu plan and the emergency medical countermeasures plan and share with partners and get signatures. Julie explained EMC.

Finalize RCHD AAR/IP procedure/plan. Start promoting volunteer registry and update volunteer activation plan. Work with DES on doing assessments for emergency assistance facilities in the county. We are to develop a Public Health Recovery Plan – at least a framework start. Julie has not looked into having the Business Continuity Planning Class (MGR-381) yet.

Public Health Summer Institute is free online or in person at Missoula on July 19-23. Several courses are offered. One that would benefit everyone is the Public Information Officer Awareness Course on July 19th 1-5 pm.

Sanitarian Report: Stephanie went over the Richland County COVID – 19 Vaccine Saturation data with the board. Using this data, RCHD will be reaching out to age groups that have lower vaccination rates.

Stephanie reported that she has been helping with COVID clinics though no longer schedules clients for the clinics. She will be doing marketing for COVID clinics to try to get more people in. Duane asked if RCHD still licenses septic installers. Stephanie said yes, they do, and they have several main installers that most people use. She said the license can be achieved within a day, and it hasn't been a barrier to installations. A homeowner can install their own system as well. She mentioned that she will report on the legislative update next month on the happenings with Public Health.
